

**C2L provides assistance for childcare costs to help young parents continue in education after the birth of a child. The scheme provides funding for childcare whilst the young parent is engaged in a study programme (and any work placements that are a defined part of that) and is not able to provide care for their child. It can also help with any additional travel costs involved in taking the child to the childcare provider. Care to Learn will pay towards the cost of childcare up to a maximum of £180 per week.**

**To qualify you must:**

Be aged under 20 on 31 August 2025 and meet the DFE’s residency criteria and Prior Pursglove College and Stockton Sixth Form College must be your main education provider.

You must be the main carer for your child and in receipt of child benefit for the child for whom you are claiming C2L.
